Assigning Details

Keep Availability updated!  
- When you decline a meet, mark unavailable in GymJas  
- When meet assigned, create a contract  
- Assigning by the total number of assignments available / the number of judges available. After that the additional assignments are awarded in order of rating (brevet, national, L10, L9, L7/8)  
- If you do not want to judge a 1-judge panel, put info in notes  
- New compulsory rating needed by October 1  
- Spring availability due September 20  
- State meet availability due August 30

- Regional availability due August 20

Non-sanctioned events can be added to activity report and receive insurance
